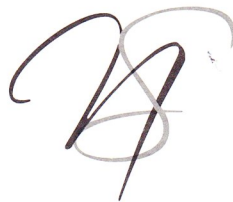
On the other hand, this position led to the development of her human skills, such as pragmatic leadership and team building , negotiating contracts and budgets.

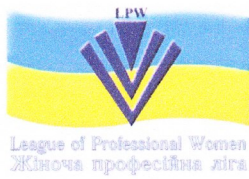

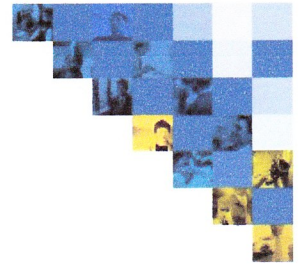
